



GOLDEN RETRIEVER CLUB OF VICTORIA INC AWARD REGULATIONS

The Golden Retriever Club of Victoria Inc. offers various awards for eligible members throughout the year.

These Regulations apply to all Golden Retriever Club of Victoria Inc Awards as published in the Guns N Sashes Newsletter at the commencement of the Awards period.

For eligibility for all awards, members must be compliant with the following and maintain compliance throughout the Awards period.

1. Only financial members of the Golden Retriever Club of Victoria Inc are eligible to compete for any award. In order to be able to earn points towards any GRCV Award, the exhibitor must be a current financial member of the GRCV on the day that they competed at the event. (i.e. An exhibitor who is not a financial member of the GRCV, cannot compete at say four [4] events, then join the GRCV and apply to have the points gained at the four [4] events countered towards the Awards).
 - 1.1. Where a registered kennel owns an exhibit, at least the active owner/exhibitor must be a financial member of the Golden Retriever Club of Victoria Inc to be eligible to compete for Club Awards.
 - 1.2. Where an exhibit is owned by two [2] or more *separate* exhibitors, all exhibitors in the ownership group must be financial members of the Golden Retriever Club of Victoria Inc in their own right, to be eligible to compete for Club Awards.
2. Only points from Victorian Canine Association Inc (DOGS Victoria) sanctioned events held within Victoria will be counted towards Golden Retriever Club Of Victoria Inc Awards
3. Only Awards points submitted on the appropriate form will be counted and must be submitted to the correct Awards Officer. It is the responsibility of the owner(s) to ensure that all forms are submitted correct and on time.
 - 3.1. Incorrect or incomplete Award forms will not be counted.
 - 3.2. Late Awards forms will not be counted.
 - 3.3. The Awards Officer is authorised to request copies of supporting documentation which must be provided to the committee nominated person(s). Non compliance with requests for supporting documentation may result in points being forfeited.
4. It will be the responsibility of members to check their points each month and advise the relevant Awards Officer of any discrepancies.
5. For entry rules relating to each Award offered, members are required to refer to specific Award Rules which are published in the Guns N Sashes Newsletter prior to the commencement of each Awards period. DEFINITIONS

GRCV	The Golden Retriever Club of Victoria Inc
Club	The Golden Retriever Club of Victoria Inc
VCA	The Victorian Canine Association Inc
DOGS Victoria	VCA trading name.
Registered Owner	The owner or owners of an exhibit as recorded on the VCA Registers.
Exhibitor	“Exhibitor” means a person in whose name an exhibit is entered for exhibition but where the context reasonably permits, shall be deemed to include a person by whom such exhibit is displayed or handled or the person in whose charge the exhibit is whilst in the precincts of an Exhibition.
Handler	“Handler” means a person who displays or handles an exhibit whilst it is being exhibited.
Active Owner/exhibitor	The person who the dog resides with and who handles the dog
Financial Member	“Financial Member” means a member of the club who shall not be in default of the payment of his annual subscription or fee or any other monies payable by him/her in accordance with the Rules. Unfinancial shall have the opposite meaning.
